

City of Boston Credit Union Member Appreciation Month Sweepstakes Official Rules

1. No purchase necessary. Purchase does not enhance chance of winning. Void where prohibited by law or regulation.
2. Eligibility: The City of Boston Credit Union (“CBCU”) Member Appreciation Month Sweepstakes is open to legal residents of Massachusetts. Entrants must be 18 years of age or older as of their date of entry in this promotion in order to qualify. This Sweepstakes is subject to federal, state, and local laws and regulations and void where prohibited by law. City of Boston Credit Union's employees, its subsidiaries, affiliates, suppliers, partners, advertising and promotion agencies, and Board of Directors (collectively the “Employees”), as well as members of an Employees' immediate family and/or those living in the same household of Employees are ineligible to participate in the City of Boston Credit Union Member Appreciation Month Sweepstakes.
3. Sponsorship. The sponsor is City of Boston Credit Union (“Sponsor”), located at 1 Union St. 3rd Flr., Boston, MA 02108. Sponsor will conduct the Sweepstakes substantially as described in these Official Rules.
4. Agreement to Rules: By entering this Sweepstakes, the Entrant (“You”) agrees to abide by the Sponsor's Official Rules and decisions, which are fully and unconditionally binding in all respects. The Sponsor reserve the right to refuse, withdraw, or disqualify any entry at any time at the Sponsor’s sole discretion. Your entry in this Sweepstakes represents and warrants that You are eligible to participate based on eligibility requirements explained in the Official Rules. You also agree to accept the decisions of the Sponsor as final and binding as it relates to the content of this City of Boston Credit Union Member Appreciation Month Sweepstakes
5. City of Boston Credit Union Member Appreciation Month Sweepstakes Entry Period: This promotion begins on Monday, April 5, 2021 at 8:00AM EST and ends on Sunday, May 2 at 11:59PM EST (“Entry Period”). To be eligible for the Sweepstakes, entries must be received within the specified Entry Period.
6. How to Enter: Eligible entrants can enter The City of Boston Credit Union Member Appreciation Month Sweepstakes by visiting the CBCU Sweepstakes entry form page. Once on the page, enter the Sweepstakes during the applicable entry period, by completing the online entry form, clicking the submit button indicates your agreement to the Official Rules.

As a participant, your entry must fully meet all Sweepstakes requirements, as specified in the Official Rules, in order to be eligible to win a prize. Incomplete entries or those that do not adhere to the Official Rules or specifications will be disqualified at the Sponsor's sole discretion. Participants may only enter once per day. The actual/appraised prize value may differ at the time the prize is awarded. The prize(s) shall be determined solely by the Sponsor. There shall be no cash or other prize substitution permitted except at the Sponsor’s discretion. The prize is non-transferable. The Winner, upon acceptance of the prize, is solely responsible for all expenses related to the prize, including without limitation any and all local, state, and federal taxes. The Winner shall not transfer assignment of the prize to others nor shall the Winner request the cash equivalent or prize substitution. A minimum of one (1) winner will be selected each week of the Member Appreciation Month promotion, on Monday at 9AM EST, by a random drawing under the supervision of the Sponsor. Entries from the previous week will not qualify for the current week's drawing. GRAND PRIZE DRAWING WILL BE CUMULATIVE OF ENTRIES FROM THE ENTIRE MEMBER APPRECIATION MONTH (Date range 4/5/21 8:00AM EST – 5/2/21 11:59PM EST). The Sponsor will notify the Winner(s) within seven days following Winner selection. The Sponsor is not responsible for nor shall have no liability for Winner's failure to receive notices due to email security settings that may cause notifications to be marked as spam or junk email. Nor shall the Sponsor be liable for the Winner's provision of incorrect or otherwise non-functioning contact information. If the Winner 1) fails to claim the prize within seven days from the time the award notification was sent, 2) is found ineligible, or 3) does not complete and return an executed declaration and release within the specified timeframe, the prize may be forfeited and an alternate Winner may be selected. The Sponsor, in the event of any of the above issues, may determine the Winner based on all eligible entries received prior to and/or after (if appropriate) the action taken by the Sponsor. Individuals who tamper with or attempt to tamper with the operation or entry process of the Sweepstakes or website or violates these Terms & Conditions will be disqualified by the Sponsor in its sole discretion.
